WHEREAS, the Regional Nutrition Committee (RNC) gives due recognition to local government units who have shown outstanding performance in managing their local nutrition program and Barangay Nutrition Scholars who have shown exemplary performance in their barangays;

WHEREAS, the RNC organized an interagency Regional Evaluation Team (RET) to conduct the annual monitoring and evaluation of the local implementation of the Phil. Plan of Action for Nutrition;

WHEREAS, the RET selects the 2010 Regional Outstanding Province, City, Municipality, Nutrition Honor Maintenance Awardees, Most Promising LGUs, Good Nutrition Practices and Regional Outstanding Barangay Nutrition Scholar based on set of criteria;

WHEREAS, this year the RET visited 4 provinces, 15 cities, 16 municipalities and 102 barangays and evaluated 16 Provincial/City BNS competing for the Regional Outstanding BNS Award;
