**“REQUESTING APPROVAL FROM THE REGIONAL NUTRITION COMMITTEE OF THE FINDINGS
OF RET FOR 2012 GREEN BANNER, GOOD NUTRITION PROJECTS/PRACTICES
AND REGIONAL OUTSTANDING BNS”**

WHEREAS, the Regional Nutrition Committee (RNC) gives due recognition to local government units who have shown outstanding performance in managing their local nutrition program and Barangay Nutrition Scholars who have shown exemplary performance in their barangays;

WHEREAS, the RNC organized an interagency Regional Evaluation Team (RET) to conduct the annual monitoring and evaluation of the local implementation of the Philippine Plan of Action for Nutrition;

WHEREAS, the RET selects the 2012 Regional Outstanding Province, City, Municipality, Good Nutrition Projects/Practices and Regional Outstanding Barangay Nutrition Scholar based on set of criteria;

WHEREAS, the RET visited 4 provinces, 14 cities, 17 municipalities and 124 barangays AND 11 Provincial/City BNS competing for the Regional Outstanding BNS Award for the period 15 May to 21 June 2013;
