**“APPROVAL OF THE FINDINGS OF THE REGIONAL EVALUATION TEAM FOR THE 2015  
GREEN BANNER, GOOD NUTRITION PROJECTS/PRACTICES AND REGIONAL  
OUTSTANDING BNS”**

WHEREAS, the Regional Nutrition Committee (RNC) gives due recognition to local government units who have shown outstanding performance in managing their local nutrition program and Barangay Nutrition Scholars who have shown exemplary performance in their barangays;

WHEREAS, the RNC organized an interagency Regional Evaluation Team (RET) to conduct the annual monitoring and evaluation of the local implementation of the Philippine Plan of Action for Nutrition;  
WHEREAS, RET selects the 2015 Outstanding Province, City and Municipality in the region based on the following criteria: a) program efficiency; b) program effectiveness/change in the nutritional status of preschool and school children; c) evaluation of nutrition action plan; d) validation weighing of sampled preschoolers; and e) interview local chief executives, nutrition action officers and members of the Provincial/City/Municipal/ Barangay Nutrition Committees.

WHEREAS, the RET selects the 2015 Regional Outstanding Province, City, Municipality, Good Nutrition Projects/Practices and Regional Outstanding Barangay Nutrition Scholar for their 2014 performance based on set of criteria;

WHEREAS, the RET visited 4 provinces, 16 cities, 17 municipalities and 132 barangays, 11 Provincial/City BNS competing for the Regional Outstanding BNS Award for the period March to June 2015;

WHEREAS, based on the evaluation and validation the following were the results:


