RNC Resolution No. 015- 04 (s 2015)

“ RESOLUTION TO EXTEND CONGRATULATIONS AND COMMENDATION TO LOCAL GOVERNMENT UNITS (LGUs)/BNSs FOR ITS OUTSTANDING PERFORMANCE ON NUTRITION PROGRAM IMPLEMENTATION - CY 2014

WHEREAS, Monitoring and Evaluation on Local Level Plan Implementation (MELLPI) has been an institutionalized activity of the National Nutrition Council and Local Nutrition Committees to assess the efficiency and effectiveness of local level nutrition plan implementation as well as the overall management of nutrition programs;

WHEREAS, the search of Regional Outstanding Barangay Nutrition Scholar (ROBNS) is also conducted to recognize BNS whose exemplary performance and delivery of nutrition services resulted to an improved nutrition situation;

WHEREAS, the RNC organized an interagency Regional Evaluation Team (RET) to conduct the annual monitoring and evaluation from March to June every year;

WHEREAS, RET selects Outstanding Province, City and Municipality, which are presented with green banner award, and the Regional Outstanding Barangay Nutrition Scholars (ROBNS) is presented with a trophy and cash prize while outstanding BNS in all Provinces & Cities also received cash prizes as incentive for their outstanding performance. Plaque of recognition is also bestowed to LGUs for good nutrition projects based on set criteria;

WHEREAS, during its 2nd Semester RNC Full Committee meeting held at Club Ultima Cebu City the Regional Nutrition Committee approved the recommendation of the Regional Evaluation Team to confer this 2015 Regional Outstanding City/Municipality, Good Nutrition Projects/Practices and Regional/Provincial and City Outstanding Barangay Nutrition Scholar that affirmed the efficient and effective management of the local nutrition program exhibited by sustained decline of malnutrition;

WHEREAS, the Outstanding Municipality in the Province of Bohol is Carmen, Bohol with a score of 90.4% while the municipality of Pamplona which scored 97.1% was named Outstanding Municipality in the Province of Negros Oriental and in the Region. This year, the City of Canlaon garnered a score of 93.2% which entitles them to the Outstanding City in the Region Award. the 2015 Regional Outstanding BNS is Ms. Mary Ann F. Reyes from Barangay Looc, Danao City, while Ms. Andresa A. Mananquil of Datagon, Pamplona qualified for the Provincial Outstanding BNS Award in the province of Negros Oriental. The following BNSs are eligible with the City Outstanding BNS Award: Mercedita M. Baya (Linothangan, Canlaon City), Ms. Evelyn L. Bolo (Sudlon II, Cebu City), Ms. Cornelia B. Diaz (Poblacion 8, Dumaguete City), Ms. Anonila C. Marinas (Poblacion, Lapu-Lapu City) and Nizan S. Raagas (Tingub, Tanjay City), while projects worth to be awarded also were “Nutrition Program Monitoring in Day Care Centers “ of Mandaue City and Walks and Wellness an institutionalized activity of Mandaue City, Negros Oriental.

WHEREAS, conferment of recognition to outstanding Local Government Units and Barangay Nutrition Scholars to receive the certificate of Recognition and the cash prizes will be given during the Nutrition Action Officers Congress on 4 August 2015 at Grand Convention Center of Cebu, Archbishop Reyes Avenue, Cebu City;


