Resolution No. 1, Series of 2018

EXPANSION OF THE MEMBERSHIP OF THE REGIONAL NUTRITION COMMITTEE TO INCLUDE THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR), COMMISSION ON POPULATION (POPCOM), DEPARTMENT OF AGRARIAN REFORM (DAR), DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), BUREAU OF PLANT INDUSTRY (BPI) AND BUREAU OF ANIMAL INDUSTRY (BAI)

WHEREAS, Presidential Decree No. 491 created the National Nutrition Council (NNC) as the highest inter-agency policy-making body on nutrition;

WHEREAS, the Executive Order No. 234 on the Reorganization of the National Nutrition Council stipulated that NNC Governing Board is composed of 9 government agencies, one coordinating body and three selected representative from the private sector a two-year term;

WHEREAS, the RNC X through Resolution No. 5, s. 2014 expanded its membership to include the Northern Mindanao Nutrition Action Officers Association of the Philippines (NAOPA, Inc.), District/City Nutrition Program Coordinators Association of the Philippines (DCNPCAP) and National Barangay Nutrition Scholars (BNS) Federation, Inc. as frontline nutrition workers joining hands in addressing the malnutrition problem of the country with the entire effort being coordinated by National Nutrition Council (NNC) and were organized into association as early as 2010;

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) for 2017-2022 is the country's framework for nutrition action. It serves as a guide for national governments, local government units, non-government organizations, development partners and other stakeholders who want to be involved in nutrition action as it lays the targets, directions and priority actions to address malnutrition particularly stunting and wasting, micronutrient deficiencies and obesity.

WHEREAS, malnutrition is a multi-faceted problem requiring a multi-sectoral mix of interventions. The PPAN with 12 programs, 8 are nutrition-specific, one is nutrition-sensitive and three are enabling support programs. A program for local government mobilization is among the three enabling programs to ensure their wider participation in delivering nutritional outcomes.

WHEREAS, the Regional Plan of Action for Nutrition (RPAN) 2019-2022 consists of 11 programs and 41 projects to be implemented by member agencies of the Regional Nutrition Committee (RNC) in cooperation with local government units.

WHEREAS, the RNC recognizes the need to include BFAR, POPCOM, DAR, DENR, DPWH, BPI and BAI as member of the RNC X as their agency acts as channel or platform for delivering nutrition-specific interventions and implements nutrition sensitive projects. These projects target food insecure households whose children and mothers are disadvantaged nutritionally, improves their livelihood and employment, and therefore increases their income to enable them to access food .

WHEREAS, the RNC during its April 23, 2018 special meeting recommended that a resolution by the Regional Nutrition Committee be issued expanding the RNC X membership to include BFAR, POPCOM, DAR, DENR, DPWH, BPI and BAI.


BE IT RESOLVED, THEREFORE, AS IT IS HEREBY RESOLVED, on motion duly seconded that the membership of the RNC is hereby expanded to include the Bureau of Fisheries and Aquatic Resources (BFAR), Commission on Population (POPCOM), Department of Agrarian Reform (DAR), Department of Environment and Natural Resources (DENR), Department of Public Works and Highways (DPWH), Bureau of Plant Industry (BPI) and Bureau of Animal Industry (BAI)

RESOLVED FURTHER , that copies of this resolution be forwarded to all members of RNC X and other concerned agencies in the region.


RESOLVED FINALLY, that copies of this resolution be furnished to NNC, members of the RNC, the BFAR, POPCOM, DAR, DENR, DPWH, BPI and BAI., provincial/city LGUs, and all concerned entities for support as well as to ensure their active participation.
