**"APPROVAL OF THE PROPOSED CY 2013 CENTRAL VISAYAS  
RNC WORKPLAN"**

WHEREAS, the National Nutrition Council (NNC) is the country's policy, planning, monitoring, evaluation and coordinating body on nutrition. Advocacy and capacity building are roles intrinsic to these basic functions;

WHEREAS, the Executive Order No. 234 defines NNC to include the Governing Board and the NNC Secretariat;

WHEREAS, the NNC-GB is the collegial body composed of 10 key agencies of the national government as well as representative from the private sector;

WHEREAS, at the subnational level, the Regional Nutrition Committee (RNC) of Central Visayas formulates policies and provides directions for nutrition program implementation at the regional and local level.

WHEREAS, the RNC-TWG drafted the 2013 RNC Annual Workplan during its 1<sup>st</sup> Quarter Meeting held on 22-23 January in Cebu Grand Hotel, Cebu City, as guide of member agencies and local government units in the performance of the committee's function. A copy of which is hereby attached;

WHEREAS, the proposed activities of the RNC are summarized as follows:

- a) Nutrition policy and planning development,
  - a. Strengthen and expand policy and program formulation and advocacy
  - b. Building and strengthened alliance and partnership
  - c. Strengthen the Food and Nutrition Surveillance System
- b) Nutrition capability building services for LGUs and other stakeholders
  - a. Systematized Capacity Development
  - b. Training and Conferences
  - c. Convention/Congress and Workshops
