RNC Resolution No. 013-02 (s 2013)

**"APPROVING THE REGIONAL NUTRITION ACTION PLAN FOR CY 2013"**

WHEREAS, the Philippine Plan of Action for Nutrition (PPAN) 2011-2016 is the country's national framework plan on nutrition, anchored on the Philippine Development Plan and will contribute to the attainment of the Millennium Development Goals specifically in addressing poverty, hunger and malnutrition;

WHEREAS, PPAN's overall goal is to contribute to improving the quality of the human resource base of the country and to reducing child and maternal mortality;

WHEREAS, the implementation of the PPAN will be guided by the following principles: attainment of nutritional well-being is a main responsibility of families; the community is a partner in addressing nutritional problems and concerns; good nutrition is an important input to the achievement of other sectoral objective; the complementation of efforts with other programs is consciously done; and undernutrition is also a function of care;

WHEREAS, anchored on the above guiding principles, strategies and priorities of action and the current nutrition situation in the region, a nutrition strategic plan was also formulated and approved by the Regional Nutrition Committee thru Resolution No. 012-01 (s 2012);

WHEREAS, the identified priorities for action to achieve set targets will be translated into annual Regional, Provincial, City, Municipal and Barangay Nutrition Action Plan;

WHEREAS, the Regional Nutrition Action Plan for CY 2013 has the objectives of reducing the prevalence of combined severely underweight and underweight preschool children from 5.66 percent to 4.48 percent by the end of December 2013, while for school children is to reduce the prevalence of combined wasted and severely wasted from 11.4 percent to 9.8 percent in December 2013.

WHEREAS, to achieve the above objectives, the implementation of programs, projects and activities shall grounded on the basic premise of complementation and convergence




of efforts and resources among RNC member agencies, local government units, non-government organizations and other stakeholders;


NOW, THEREFORE, for and in consideration of the above premises, we the members of the Regional Nutrition Committee do hereby concurs the adoption of the RNAP 2013 as the overall framework in formulating specific plans and programs for implementation to mitigate hunger and malnutrition in the region.
