RNC Resolution No. 016-02 (S.2016)

**“EXPRESSING GRATITUDE TO THE DEPARTMENT OF HEALTH REGION VII FOR  
PROVIDING FIVE NURSES AS SUPPORT PERSONNEL IN THE IMPLEMENTATION  
OF THE PPAN”**

**WHEREAS**, the National Nutrition Council (NNC) is the country’s policy, planning, monitoring, evaluation and coordinating body on nutrition with advocacy and capacity building are roles intrinsic to these basic functions;

**WHEREAS**, the organization and functions of the NNC are replicated in the regions with the Regional Nutrition Committees (RNC) as the governing board and the NNC regional offices as its secretariat;

**WHEREAS**, one of the mandates of the RNC is to call on any department, bureau, office, agency and other instrumentalities of the government for assistance in the form of personnel, facilities and resources as the need arises;

**WHEREAS**, nutrition is an important social development concern and nutrition considerations need to be integrated in all development plans of local government units (LGUs), including sectoral plans and programs of different national government agencies.

**WHEREAS**, the Philippine Plan of Action for Nutrition (PPAN) because of its complexity in the implementation such that additional personnel or full-time nutrition officers/coordinators are needed to link the regional PPAN implementation with the different local nutrition committees;

**WHEREAS**, recognizing the importance of personnel in ensuring the effective and efficient execution of PPAN at the sub regional level, the DOH 7 with its Regional Director and Chairperson of the RNC Jaime S. Bernadas, provided five nurses to support the implementation of PPAN under the Nurse Deployment Project (NDP) for CY 2016;


**WHEREAS**, the nurses will perform as Nutrition Officers to augment the human resource requirement of the local government units to coordinate the planning, implementation, monitoring, and evaluation of the PPAN at the areas they are assigned;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to express gratitude to the DOH 7 for providing five nurses as support staff who will link the nutrition program implementation with the provincial, municipal and barangay levels;

**RESOLVED FURTHER**, to furnish a copy of this resolution to the DOH RO 7 for their information.
