RNC Resolution No. 012-03 (S.2012)

“APPROVING THE PROPOSED SIMULTANEOUS CONDUCT OF THE 2012 MONITORING  
AND EVALUATION OF THE LOCAL LEVEL PLAN IMPLEMENTATION AND  
EVALUATION OF NOMINEES TO THE REGIONAL OUTSTANDING  
BARANGAY NUTRITION SCHOLARS AWARD”

WHEREAS, in 1979 the National Nutrition Council established and institutionalized the Monitoring and Evaluation of Local Level Plan Implementation (MELLPI) system as a monitoring and evaluation activity with the following purpose: 1) to assess the efficiency of local level implementation of the Philippine Plan of Action for Nutrition (PPAN) in terms outreach activities conducted, funds expended as well as the management and support given by local executives and other implementing agencies; 2) to measure the changes of nutrition status of target population; 3) determine the extent to which nutrition is integrated in local development plans and programs; 4) document best practice; and, 5) advocate for continuing support for local nutrition program;

WHEREAS, conducted at the provincial, city, municipal and barangay level, the MELLPI evaluates the efficiency and effectiveness of PPAN implementation in the area by assessing, among others, the functionality of the local nutrition committee which in turn is dependent on the coordination efforts of members of the nutrition committee and an active Barangay Nutrition Scholar (BNS) as mandated by PD 1569;

WHEREAS, in recognition of their contribution in the enhancement of the delivery of nutrition services, a Regional Outstanding Barangay Nutrition Scholar Award is given every year to deserving nutrition scholars;

WHEREAS, RNC-Regional Evaluation Teams (RETs) are being organized to conduct the MELLPI and evaluate nominees to the Regional Outstanding Barangay Nutrition Scholar Award annually;

WHEREAS, during its meeting on 17 February 2012, the RNC- Technical Working Group proposed that the MELLPI and BNS award evaluation be conducted simultaneously on May 3 to June 8, 2012 in four (4) provinces, sixteen (16) cities, 14 municipalities, and selected barangays of the region;

WHEREAS, in the same meeting, the RNC-TWG identified the proposed composition of the Regional Evaluation Teams (RETs) from the member agencies of the Regional Nutrition Committee;

WHEREAS, upon review, the RNC find the proposed simultaneous conduct of the MELLPI and evaluation of the Regional Outstanding BNS award nominees along with the proposed schedule, RET composition and member assignments reasonable and practical;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to approve the simultaneous conduct of the 2012 MELLPI and evaluation of the nominees to the Regional Outstanding Barangay Nutrition Scholars Award, a copy of the schedule, RET composition and member assignments are attached as integral part of the resolution.
