**INVITATION TO BID FOR THE PRINTING AND DELIVERY  
OF BARANGAY NUTRITION SCHOLAR HANDBOOK**

1. The National Nutrition Council, through the GOP fund for the year 2015 intends to apply the sum of **SIX HUNDRED FIFTY THOUSAND PESOS (Php 650,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Printing And Delivery Of Barangay Nutrition Scholar Handbook. The said materials will be delivered to consignees as per attached distribution list and consignees/destination. Bids received in excess of the ABC shall be automatically rejected at bid opening.
  
2. The National Nutrition Council now invites bids for the above-stated project. Delivery of Goods is required as indicated in the **Bid Data Sheet** of the Bidding Documents. Bidders should have completed, within three (3) years (**November 2012 – November 2015**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

3. Interested bidders may obtain further information from the National Nutrition Council and inspect the Bidding Documents at the address given below during 8:00 a.m. – 5:00 p.m., Monday - Friday.

A complete set of Bidding Documents may be purchased by interested Bidders on **4-7 December 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **ONE THOUSAND PESOS ONLY (Php 1,000.00)**. Payment of bid documents will be cash. The Bidding Documents shall be received personally by the prospective bidder or his/her authorized representative.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

4. The National Nutrition Council will hold a **Pre-Bid Conference on 7 December 2015 at 3:00 p.m.** at NNC Boardroom, 2332 Chino Roces Avenue Extension, Taguig City which shall be open to all interested parties who have purchased the Bidding Documents.
5. Bids must be delivered to the address below on or before **21 December 2015 at 2:00 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**
6. Bid opening shall be on **21 December 2015 at 2:00 p.m.** at the National Nutrition Council – Nutrition Building, 2332 Chino Roces Avenue Extension, Taguig City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
7. The National Nutrition Council reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
